Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, 10ct white gold, gem set, stud earrings, of hand-assembled construction.

Feature square top plate, with a central eight claw setting, housing one round brilliant cut diamond, claw set. The double surround houses two rows housing a total of twenty-eight round brilliant cut diamonds, graduating in size, claw set. The earrings are finished with post and butterfly attachments.

Earring dimensions = 8.00mm (ave. length) x 7.99mm (ave. width) x 4.38mm (ave. depth).

Polished finish.

Stamped '10K MHJ' - acid tested as 10 carat gold.

The earrings contains:

Two claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 2.28mm(Dia) x 1.39mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.09ct (estimated - see NOTE below)

Fifty Six claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

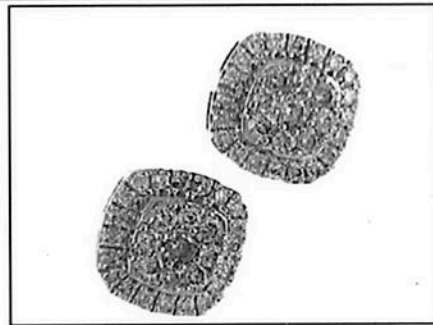
Dimensions = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.56ct (estimated - see NOTE below)

Total Item Weight = 2.57 grams Total Gemstone Weight = 0.65ct Total Metal Weight = 2.44 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
