## Valuation For Traditional Insurance Replacement Purposes

### Item 1

One, hand-assembled, 18ct yellow gold and 18ct white gold, multistone, gem set ring.

Plain, wide, low half round, tapered band of 3.38mm in width (at base) x 1.00mm depth, with open back setting.

Feature white gold, solid-sided, bezel setting, housing one round brilliant cut diamond, rub-over set. The setting is secured between the shoulders of the yellow gold plain and polished band, having single 'collar' style shoulder terminations.

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Finger size is N.

The ring contains:

One rub over set round brilliant cut diamond, clarity 'P2', colour 'H'.

Dimensions = 5.05mm(Dia) x 3.20mm(D-estimated) x 2%(Girdle Thickness)

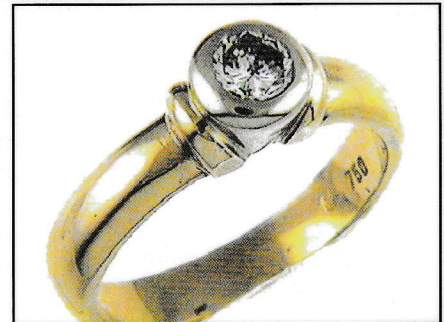
Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 6.00 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 5.90 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
