Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct rose gold and 9ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.01mm width (at base) x 1.12mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature rose gold octagonal top plate, housing five baguette cut diamonds, and four round brilliant cut diamonds, to the centre, claw set. The surround and 'split' and 'cross over' shoulders, housing thirty-two round brilliant cut diamonds, graduating in size, and claw set. The top plate is secured to the underrail, and in between the shoulders of the plain and polished white gold band.

Polished finish.

Stamped '9K 0.50 CT' - acid tested as 9 carat gold.

Ring size: L.

The ring contains:

Five claw set tapered baguette cut diamonds, clarity is "Vs & Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 2.50mm(L) x 1.50mm(W) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.50mm(L) x 1.00mm(W) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.11ct (estimated - see NOTE below)

Thirty Six claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.39ct (estimated - see NOTE below)

Total Item Weight = 2.71 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 2.59 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
