Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 0.91mm width (at base) x 0.75mm depth, with a hollow top and shoulders, open back settings, and a cut out curved underrail.

Feature cushion shaped to plate, housing nine round brilliant cut diamonds, to the centre, claw set. The double surround and shoulders house a total of fifty round brilliant cut diamonds, graduating in size, and claw set. The top plate is secured to the underrail, and in between the 'split' style shoulders, of the plain and polished band.

Polished finish.

Stamped 'TWIIND 1.00 9K' - acid tested as 9 carat gold.

Ring size: R 1/2.

The ring contains:

Fifty Nine claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "yellow and brown tint".
Dimensions = 2.35mm(Dia) x 1.43mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 2.17 grams

Total Gemstone Weight = 1.00ct

Total Metal Weight = 1.97 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
