Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, 'dress' style ring, of cast construction.

Plain, narrow, flat band of 1.99mm width (at base) x 0.31mm depth, with a curved underrail.

Feature central four claw setting, housing one oval synthetic spinel, claw set. Surrounding, is looped and 'rope' style detail. The setting is secured to the underrail, and in between the shoulders of the plain and polished band. The shoulders are embellished with a 'leaf' shaped shoulder plate, and engraved detail.

Polished finish.

Stamped '750 *2250 AL' - acid tested as 18 carat gold.

Ring size: Q.

The ring contains:

One claw set oval shaped synthetic spinel, colour is "pale blue".
Dimensions = 11.07mm(L) x 9.05mm(W) x 6.39mm(D-estimated)
Total Weight = 4.89ct (estimated - see NOTE below)

Total Item Weight = 4.38 grams
Total Gemstone Weight = 4.89ct
Total Metal Weight = 3.40 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
