One lady's, hand finished, raised 18ct yellow gold & diamond set, solitaire style ring. Plain, narrow, low half round, tapered band, measures 2.84mm width (at base) x 1.53mm depth, with curved underrail.

Feature, "solitaire style" ring design. Comprising a raised six claw setting, rhodium polished to highlight. Housing one round brilliant cut diamond, (laser inscribed & certified), claw set. The extended shoulders, of the yellow gold band, tapers up to the top, from both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold.

Finger size = N.

One claw set round brilliant cut diamond, clarity is "Si1", colour is "F", excellent cut quality.

Dimensions = 5.78 - 5.81mm (Diameter) x 3.61mm (D-actual) x 4%(Girdle Thickness)

Total Weight = 0.75ct (known - see NOTE below).

Total Item Weight = 4.30 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 4.15 grams (estimated)

NOTE: The round brilliant cut diamond, has been certified by, and is the opinion of, Messrs. Gemological Institute of America, Certificate no.2205057078 Dated; February, 11, 2019. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 2205057078.
