Stamped '750 *1585 VI by Ronco'.

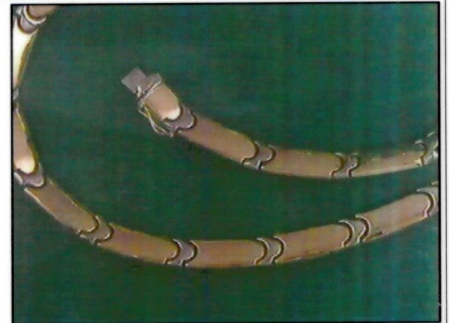
Acid tested as 18 carat gold.
