Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, 'dress' style ring, of cast construction.

Plain, narrow, low half round band of 2.19mm width (at base) x 1.03mm depth.

Feature central decorative cup style setting, housing one semi-round cultured pearl, glue set. The 'split' style termination, houses two rows of ten round synthetic cubic zirconias, all claw set. The settings are secured between the shoulders of the plain and polished band.

Polished finish.

Stamped 'G18K' - acid tested as 18 carat gold.

Ring size: P 1/2.

The ring contains:

One end-drilled semi-round cultured pearl, lustre is "Medium", blemish is "Few blemishes", nacre thickness is "Medium", colour is "pink".

Dimensions = 10.88mm(L) x 10.45mm(W) x 10.25mm(D)

Twenty claw set round synthetic cubic zirconias, colour is "colourless".

Dimensions (average) = 0.80mm(Dia) x 0.49mm(D-estimated)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 4.39 grams

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
