Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct yellow gold & 10ct yellow gold, gemset, flexible link necklet/pendant. Feature; "drop style" necklet. Comprising, a padlock diamond set filigree pendant to front. Secures a machine made, hollowed out curb link chain, with double roll-over collars to each end.

Polished finish, stamped "MHJ, 10ct (chain), 375 (padlock/pendant)" - acid tested approximately 10ct & 9ct gold.

Necklet dimensions = 50.00cm (total length) x 6.95mm (width) x 3.82mm (depth).

Padlock/pendant dimensions. = 26.00mm (length) x 18.07mm (width) x 4.73mm (depth).

The necklet/padlock contains:

Seven bead & rub-over set (mixed) round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "J/K" inset), medium cut quality.

Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated) (smallest)

Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated) (largest)

Total Weight = 0.18ct (estimated - see NOTE below).

Eleven bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "J to K"(mixed), medium cut quality.

Dimensions = 1.00mm (average diameter) x 0.61mm (D-estimated) (smallest)

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (largest)

Total Weight = 0.12ct (estimated - see NOTE below).

Total Item Weight = 37.84 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 37.78 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar necklet / pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
