Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold, gem set, pendant, of hand-assembled construction.

Feature central four claw setting, housing one oval natural topaz, claw set. The pendant has been finished with an articulated tapered bail, to the top.

Pendant dimensions = 31.00mm (ave. length) x 15.00mm (ave. width) x 9.21mm (ave. depth).

Polished finish.

Stamped '375' - acid tested as 9 carat gold.

The pendant contains:

- One claw set oval shaped natural topaz, colour is "blue".
- Dimensions = 18.59mm(L) x 15.08mm(W) x 8.20mm(D-estimated)
- Total Weight = 17.04ct (estimated - see NOTE below)

Total Item Weight = 6.22 grams
Total Gemstone Weight = 17.04ct
Total Metal Weight = 2.81 grams (estimated)
