Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, flexible link necklet, of hand-assembled construction.

Feature central semi-bezel setting, housing one oval natural topaz, end set. The setting has been finished with an articulated tapered bail, to the top. The pendant has been suspended from a 'curb' style link chain, in a 'filed' design. The chain has been finished with a medium sized 'bolt' ring style clasp.

Chain dimensions = 53.00cm (ave. length) x 2.89mm (ave. width) x 1.35mm (ave. depth).

Pendant dimensions = 20.00mm (ave. length) x 7.00mm (ave. width) x 5.17mm (ave. depth).

Polished finish.

Stamped '750 *13VI BALESTRA unknown symbol(chain) 750 illegible stamps(pendant)' - acid tested as 18 carat gold.

The necklet contains:

One end set oval shaped natural topaz, colour is "blue".

Dimensions = 9.07mm(L) x 7.05mm(W) x 4.60mm(D-estimated)

Total Weight = 2.18ct (estimated - see NOTE below)

Total Item Weight = 18.16 grams

Total Gemstone Weight = 2.18ct

Total Metal Weight = 17.72 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
