Valuation for Traditional Retail Insurance Replacement

Item 1

One pair of, 18ct yellow gold, gem set, drop stud earrings, of hand-assembled construction.

Feature each earring having, a 'fleur' de lis' style stud top, with two hinged articulated oval settings, graduating in size, each housing one oval natural turquoise cabochon, bezel set. The settings are embellished with a 'zig zag' style pattern. The earrings have been finished with post and butterfly attachments.

Earring dimensions = 49.00mm (ave. length) x 13.00mm (ave. width) x 4.38mm (ave. depth).

Polished finish.

Stamped '750 *800 NA' - acid tested as 18 carat gold.

The earrings contain:

- Four bezel set oval shaped natural turquoise cabochons, colour is "blue".
- Dimensions = 7.53mm(L) x 5.44mm(W) x 1.95mm(D-estimated) (smallest)
- Dimensions = 8.30mm(L) x 6.20mm(W) x 2.50mm(D-estimated) (largest)
- Total Weight = 3.06ct (estimated - see NOTE below)

Total Item Weight = 7.64 grams

Total Gemstone Weight = 3.06ct

Total Metal Weight = 7.03 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
