**Description:** A set of ladies stamped 18ct, 750 yellow gold seven diamond rings. The central diamonds are four claw chenier collet set in a cluster and the remaining diamonds are four claw chenier set in a curved row. The shoulders are cross over design and the bands are flat. The rings are hand assembled. Ring Size: O.

**Measurements:**

- 1 x Diamond – round brilliant cut, 2.8mm, estimated weight 0.09ct, Clarity SI2, Colour F-H.
- 1 x Diamond – round brilliant cut, 2.5mm, estimated weight 0.06ct, Clarity SI2, Colour F-H.
- 1 x Diamond – round brilliant cut, 2.4mm, estimated weight 0.05ct, Clarity SI2, Colour F-H.
- 4 x Diamonds – round brilliant cut, 3.0mm to 3.1mm, estimated weight 0.10ct each, Clarity P1, Colour I-J.

Due to the stones being set the weight, clarity and colour are estimated.
