A stamped 10K Michael Hill 1.50 TDW, white gold fifty nine diamond ring.

Diamonds are bead set in a square shape, set in a four claw central setting with four claw set diamonds set in a square surrounding row.

Diamonds are channel set in a central row with diamonds four claw set in outer rows, set along the flared, upraised shoulders.

1 x Diamond – round brilliant cut, 2.8mm, estimated weight 0.08ct, Clarity P1, Colour I-K.

4 x Diamonds – round brilliant cut, 2.6mm, estimated weight 0.07ct each, Clarity P1-P2, Clarity I-K.

4 x Diamonds – round brilliant cut, 1.7mm, estimated weight 0.02ct each, Clarity P1-P2, Clarity I-K.

16 x Diamonds – round brilliant cut, 2.0mm, estimated weight 0.03ct each, Clarity P1-P2, Colour I-K.

18 x Diamonds – baguette cut, 1.5mm to 1.6mm in length, estimated weight 0.008ct each, Clarity SI, Colour I-K.

8 x Diamonds – round brilliant cut, 2.0mm to 2.1mm, estimated weight 0.03ct each, Clarity P1-P2, Colour I-K.

8 x Diamonds – round brilliant cut, 1.9mm, estimated weight 0.025ct each, Clarity P1-P2, Colour I-K.
