Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.06mm width (at base) x 1.45mm depth.

Feature central eight claw setting, housing one round brilliant cut diamond, claw set. Either side of the central setting, is one six claw setting, each housing one round brilliant cut diamond, claw set. The settings are secured between the shoulders of the plain and polished band. Each of the shoulders houses one row of seven round brilliant cut diamonds, claw set.

Polished finish. Stamped 'CR PT' - acid tested as platinum. Ring size: L.



The ring contains:

- One claw set round brilliant cut diamond, clarity is "Vs", colour is "G".
Dimensions = 5.31mm(L) x 5.29mm(W) x 3.20mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.56ct (estimated - see NOTE below)
- Two claw set round brilliant cut diamonds, clarity is "Vs", colour is "G to H" (mixed).
Dimensions (average) = 3.90mm(Dia) x 2.38mm(D-estimated) x 2.5%(Girdle Thickness)
Total Weight = 0.44ct (estimated - see NOTE below)
- Fourteen claw set round brilliant cut diamonds, clarity is "Vs", colour is "G to H" (mixed).
Dimensions (average) = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.28ct (estimated - see NOTE below)

Total Item Weight = 4.16 grams Total Gemstone Weight = 1.28ct Total Metal Weight = 3.90 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the setting below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
