One bangle.

Fabricated from 23 carat yellow gold.

Solid construction.

Of an un-hinged 'slave' design.

Round in shape.

Decorative alternating outer top profile patterns, of a grooved and bevelled design.

Standard style inner curve, with bevelled edging.

Bangle dimensions = 56.00mm (ave. internal diameter) x 2.35mm (ave. width) x 1.60mm (ave. depth).

Polished finish.

Stamped 'KDM 23C SRJ'.

Acid tested as approximately 23 carat gold.

Total Item Weight = 10.00 grams.

NOTE: This piece is believed to be of Asian manufacture and would be extremely difficult to replicate in Australia. The replacement figure is therefore based upon procuring from overseas a similar piece, allowing for precious metal content and minimum hours of manufacture.
