One bangle.

Fabricated from 22 carat yellow gold.

Solid construction.

Of an un-hinged 'slave' design.

Round in shape.

Decorative rectangular sections, alternating with a split three row design to the top profile.

Standard inner style curve.

Bangle dimensions = 63.00mm (internal diameter) x 6.50mm (ave. width) x 1.30mm to 1.10mm (ave. depth).

Polished finish.

Stamped 'illegible'.

Acid tested as 22 carat gold.

Total Item Weight = 19.58 grams.



NOTE: This piece is believed to be of Asian manufacture and would be extremely difficult to replicate in Australia. The replacement figure is therefore based upon procuring from overseas a similar piece, allowing for precious metal content and minimum hours of manufacture.
