### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, platinum, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 2.03mm width (at base) x 1.78mm depth.

Feature central four claw setting, housing one oval synthetic diamond, claw set. The setting is secured to the top of the plain and polished band. Each of the shoulders houses one row of nine synthetic round brilliant cut diamonds, claw set.

Polished finish.

Stamped 'PT950' - acid tested as platinum.

Ring size: I 1/2.

The ring contains:

- One claw set oval shaped synthetic diamond, clarity is "VV<sub>s</sub>2", colour is "D".  
Dimensions = 8.89mm(L) x 6.01mm(W) x 3.69mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 1.24ct (known weight - see NOTE below)
- Eighteen claw set synthetic round brilliant cut diamonds, clarity is "V<sub>s</sub>", colour is "G".  
Dimensions (average) = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.45ct (estimated - see NOTE below)

Total Item Weight = 4.15 grams Total Gemstone Weight = 1.69ct Total Metal Weight = 3.81 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the synthetic diamonds cannot be ascertained. Therefore, weights of the synthetic diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the synthetic diamonds require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
