One hand assembled 18k yellow and white gold halo style multi-stone diamond ring, plain flat profile tapered shank of width 4.23mm – 2.41mm x 1.02mm. Centre set with round brilliant cut diamond in a “4” claw coronet, lower 12 x pave’ set round brilliant cut diamonds surround in white gold, total of 12 x channel set baguette cut and tapered baguette cut diamonds and 28 x pave’ set round brilliant cut diamonds on either side of the slightly extended shoulders, polished finish and stamped 750.



01 x round brilliant cut diamonds, colour = TLB, clarity = SI2, estimated.
Dimensions = 5.45 x 5.42 x 3.27mm, average.

12 baguette cut diamond, colour = J – TTLB, clarity = VS – SI, estimated.

40 x round brilliant cut diamonds colour = TLB - TTLB, clarity = VS – SI, estimated.
Dimensions = 1.60mm – 0.95mm, average diameter.
Weight = 0.29ct estimated.

Total Item Weight = 4.90gm estimated.
Total Gem Weight = 1.25ct estimated.
