Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct yellow gold, and rhodium plated, gem set, pendant, of hand-assembled construction.

Feature round top plate, within a four claw setting, housing four Princess cut diamonds, to the centre, invisibly set. The surround houses twelve round brilliant cut diamonds, graduating in size, and claw set. The pendant has been finished with an articulated tapered bail. Rhodium plating to the diamond setting area.

Pendant dimensions = 10.00mm (ave. length) x 7.50mm (ave. width) x 5.00mm (ave. depth).

Polished finish.

Stamped '14K illegible stamp' - acid tested as 14 carat gold.

The pendant contains:

Four invisibly set Princess cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions = 1.80mm(L) x 1.80mm(W) x 1.28mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.16ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions = 1.15mm(Dia) x 0.70mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.80mm(Dia) x 1.10mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 1.12 grams Total Gemstone Weight = 0.32ct Total Metal Weight = 1.06 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. Below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of item.
