Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, gem set, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.85mm width (at base) x 1.06mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature square top plate, within a four claw setting, housing four Princess cut diamonds, invisibly set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band. Each of the shoulders houses one row of five round brilliant cut diamonds, graduating in size, channel set.

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

Four invisibly set Princess cut diamonds, clarity is "Si" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 2.20mm(L) x 2.20mm(W) x 1.56mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.28ct (estimated - see NOTE below)

Ten channel set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed).

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.14ct (estimated - see NOTE below)

Total Item Weight = 2.25 grams Total Gemstone Weight = 0.42ct Total Metal Weight = 2.17 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
