Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, gem set, multistone ring, of cast construction.

Plain, wide, low half round band of 4.62mm width (at base) x 1.02mm depth, with open back settings.

Feature two inner rows, each housing seventeen Princess cut diamonds, channel set. There are also two outer rows, each housing eleven round brilliant cut diamonds, claw set. The diamonds span across the top of the band, graduating in size, largest to the centre. The settings are secured between the tapering shoulders, of the plain and polished band.



Polished finish.

Stamped '750' - acid tested as 18 carat gold.

Ring size: Q.

Twenty Two claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 2.80mm(Dia) x 1.71mm(D-estimated) x 2%(Girdle Thickness) (largest)

Thirty Four channel set Princess cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "H to J" (mixed).

Dimensions = 2.20mm(L) x 2.20mm(W) x 1.56mm(D-estimated) x 2%(Girdle Thickness) (largest)
