Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 3.43mm width (at base) x 1.46mm depth, with open back settings.

Feature one central row housing fifteen baguette cut diamonds, channel set, and two outer rows, each housing eleven round brilliant cut diamonds, claw set. The diamonds span across the top of the band, and graduate in size, largest to the centre. The settings are secured between the tapering shoulders, of the plain and polished band.

Polished finish.

Stamped '14K 2.00 michael hill' - acid tested as 14 carat gold.

Ring size: N 1/2.

The ring contains:

Twenty Two claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.80mm(Dia) x 1.71mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Fifteen channel set baguette cut diamonds, clarity is "Vs & Si" (mixed), colour is "H to I" (mixed).

Dimensions = 3.00mm(L) x 1.60mm(W) x 1.17mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.50mm(L) x 1.80mm(W) x 1.31mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 1.00ct (estimated - see NOTE below)

Total Item Weight = 6.24 grams Total Gemstone Weight = 2.00ct Total Metal Weight = 5.84 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
