Such instalments as shown above include a provision for a credit charge that will be charged at the rate of 1.85% per month (which is equivalent to an annual percentage rate of 22.2%) on the balance outstanding 60 days after the goods are ready for delivery. I understand the first monthly instalment under the contract will be due and payable 1 month from the date you notify me the goods are ready for delivery (the due date shown on my statement) and subsequent monthly instalments will be due and payable on the same day of each succeeding month. I also understand that no part of the credit charge becomes due and payable unless it is an accrued credit charge and if I elect to pay the amount financed in full within 60 days from the date the goods are ready for delivery no credit charge will apply at all. I further understand that all instalments under the contract are to be paid to Australian Retail Financial Network Ltd., G.P.O. Box 236E, Melbourne 3001 or at the Credit Office in any Myer Store. Acceptance of this offer by Australian Retail Financial Network Ltd. shall be constituted by delivery of the goods direct to me or, at my request, to some other person or company. No mortgage relating to the credit applied for has been or is agreed to be entered into.

I also request Australian Retail Financial Network Ltd. at its discretion to offer me a continuing credit account by sending me an appropriate credit card and, if I accept such offer, I agree to abide by the terms and conditions of such accounts as notified by Australian Retail Financial Network Ltd. from time to time.
