### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 14ct yellow gold, gem set, 'two stone' style ring, of cast construction.

Plain, wide, low half round, tapered band of 4.44mm width (at base) x 1.68mm depth, with a hollow top and shoulders, and open back settings.

Feature two decorative points to the top of the band. In between the two points, is one vertical row of two Princess cut diamonds, channel set. The settings are secured between the tapering shoulders of the plain and polished band.

Polished finish.

Stamped '585' - acid tested a 14 carat gold.

Ring size: Z.

The ring contains:

Two channel set Princess cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions (average) = 2.50mm(L) x 2.50mm(W) x 1.77mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 8.38 grams

Total Gemstone Weight = 0.18ct

Total Metal Weight = 8.34 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
