## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 1.17mm width (at base) x 0.78mm depth, with a hollow top and shoulders, and open back settings.

Feature central white gold four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the top of the plain and polished yellow gold band. Each of the shoulders houses two round brilliant cut diamonds, claw set.

Polished finish.

Stamped '18CT 750' - acid tested as 18 carat gold.

Ring size: M 1/2.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si2", colour is "G".

Dimensions = 3.93mm(Dia) x 2.40mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Four claw set round brilliant cut diamonds, clarity is "Vs & Si & P1" (mixed), colour is "G to I" (mixed).

Dimensions (average) = 1.88mm(Dia) x 1.15mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.11ct (estimated - see NOTE below)

Total Item Weight = 1.90 grams Total Gemstone Weight = 0.34ct Total Metal Weight = 1.83 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
