## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct white gold, gem set, 'dress' style ring, of cast construction.

Plain, narrow, low half round band of 2.76mm width (at base) x 1.14mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central decorative four claw setting, housing one fancy square cushion shaped natural garnet, claw set. The setting is secured between the extended and pointed shoulders, of the plain and polished band. Each of the shoulders houses one row of six round brilliant cut diamonds, graduating in size, and bead set.

Polished finish.

Stamped 'FP 14K 5585' - acid tested as 14 carat gold.

Ring size: L.

The ring contains:

One claw set square cushion natural garnet, colour is "red".

Dimensions = 9.85mm(L) x 9.79mm(W) x 5.97mm(D-estimated)

Total Weight = 5.50ct (estimated - see NOTE below)

Twelve bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 1.20mm(Dia) x 0.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.68mm(Dia) x 1.02mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.16ct (estimated - see NOTE below)

Total Item Weight = 4.56 grams Total Gemstone Weight = 5.66ct Total Metal Weight = 3.43 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
